3 criteria in the price list tables:

Absence of BFR in plastic - premium

The "Absence of BFR in plastic" (Brominated Flame Retardant) criterion applies only to products meeting the following 3 conditions:

1. Proportion of plastics \geq 20 % of total equipment mass
2. Presence of plastic parts \geq 25 g requiring the use of flame retardants
3. Absence of brominated flame retardants in plastic parts \geq 25 g, with the exception of cables and electronic cards.

Spare parts availability - bonus

We invite you to respect the criteria indicated in the "**Technical Note**" available in your personal account on [Ecollogic Producer Extranet](#).

Non-separable battery - penalty

The "non-separable battery" criterion applies to a product containing a battery or accumulator which cannot be easily separated by the user using a commercially available tool.

Certain families of equipment may be exceptionally exempted according to criteria specified in the "**Technical Note**".

Recycled Plastics Material (RPM)

The criterion of incorporating Recycled Plastics Materials (RPM) applies to all Professional Electrical and Electronic Equipment (EEE).

For RPM from post-consumer waste from EPR channels (open circuit), excluding food-grade resins, the calculation base is established on the basis of 450 € (excl. VAT) per ton, to be reduced to the mass of RPM in the equipment. For RPM from post-consumer WEEE (closed circuit), the calculation base is established on the basis of 550 € (excl. VAT) per ton, to be reduced to the mass of RPM in the equipment.

Following a regulatory change applicable from **January 1st 2026**, a product subject to a penalty can no longer qualify for a bonus, with the exception of bonuses linked to the use of recycled materials, in accordance with the [decree of September 5th 2025](#).

NOTICE

Reminder:

- An accessory (e.g. remote control) sold with a piece of equipment is an integral part of the equipment.
- An electrical spare part sold separately is declared separately using the dedicated eco-contribution code.

Batch with several items of equipment (excluding accessories) or several items of similar equipment

When EEE is sold in the form of a batch containing several different or similar items of equipment, the net weight of each item of equipment must be taken into account individually, and the eco-contribution applied to each product according to its type.

Example 1: Batch of various EEE.

Each EEE must be declared separately and the eco-contribution applied individually to each product according to its category.

Example 2: Batch of identical EEE.

For a batch of 20 socket-outlet blocks, each socket-outlet block must be declared separately, and the eco-contribution calculated on the basis of the net unit weight of each socket-outlet block.
