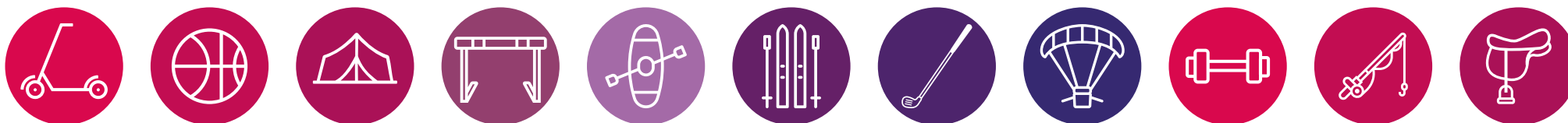

To update the eco-contributions on all your products and references concerned, please use the price list guide available in the "document" tab of your **member area**. By checking all references, you guarantee full regulatory compliance.

It increases (penalty) or decreases (bonus) according to 4 modulation criteria (see **Eco-modulation: explanatory note**).

You can thus apply a reduced ecocontribution for your most recyclable products, those incorporating recycled materials and the provision of spare parts...

If it is not possible to justify the modulation criteria, or in case of doubt, the least favorable eco-tax should be applied.



ASL definition and scope

Sport and leisure articles are equipment used for sports or outdoor leisure activities, including accessories and consumables, as defined in R543-330 of the French Environment Code:

1. **Cycles** as defined in article R. 311-1, 6.10 of the Highway Code, and **non-motorized personal mobility devices** as defined in article R. 311-1, 6.16 of the Highway Code.
2. **Products intended for sports and outdoor activities.**

Equipment concerned (non-exhaustive list)

Sporting and leisure goods are equipment used for outdoor sports or leisure activities, including accessories and consumables, as defined in R543-330 of the French Environment Code:

Cycles and mobility	Bicycles, scooters, skates, rollerblades (tires and spare parts are included) Protection and accessories for bicycles and cyclists: helmets, knee pads, elbow pads, pumps, etc.
Water sports and leisure	Diving, snorkeling, swimming (fins, snorkel, mask and goggles, wetsuit...) Fishing (rod, fishing line, hook...) Surfboard, bodyboard, paddle, kayak, water-ski, windsurf...
Snow sports (mountain)	Skis, poles and boots, ice skating, tobogganing...
Outdoor leisure	Camping equipment, bows and arrows, trampoline, petanque balls, climbing axes...
Riding	Balls, saddles, whips, bits...
Racquet sports	Racket, ball, ping-pong table...
Ball sports	Basketball, soccer, handball, rugby...
PPE / Protection	Helmet, rope, carabiner...
Sports fitness, bodybuilding	Fitness mats, dumbbells, non-electric weight machines...
Hunting & shooting	Hunting and shooting cartridges, targets, cartridge belts, ear muffs, game bags, hunting boots...

Excluded from the ASL perimeter

- Items subject to EPR (TLC, WEEE, DBPS, DEA, JJ)
- Crockery and storage boxes (not EPR)
- AMORCE / Fishing APPAS
- Boating: equipment, accessories related to equipment covered by EPR DBPS
- Liquids and lubricants
- Firearms



Reporting and invoicing frequency

There are **two** reporting **periods** per year:

- **From early July (for 6 weeks):** declaration for the first half of year N.
- **From early January (for 6 weeks):** declaration for the second half of year N-1/annual declaration for year N-1.

Your declaration frequency is defined when you join the eco-organization, according to your tonnage placed on the market. You have two options:

- If your tonnage **is less than 5**, the declaration and invoicing will be **annual**.
- If your tonnage **is greater than 5**, the declaration will be half-yearly and invoicing **quarterly**.

Remarque: if this is your first year on the market, we have no basis on which to invoice you for the advance payment based on your N-1 year. You will only be invoiced for the annual minimum.

The annual minimum will also be invoiced by instalment each year if your marketings are below this amount.

Ecocontribution amounts vary according to these **4 modulation criteria** and are indicated in **the scale table** on each combination line.

Criterion 1: Availability of spare parts and documentation (bonus)

A bonus is awarded for products for which all spare parts are available more than 10 years after the last unit of this model was put on the market, provided that documentation indicating the procedure for replacing a spare part is available.

Criterion 2: Availability of spare parts (penalty)

For each ASL, if the average delivery time for all its spare parts is less than 7 working days, the penalty does not apply. The assessment is based on all orders for spare parts associated with the product, regardless of the type of part.

For example, a product A with parts AA, AB, AC and AD would have to calculate the average delivery time for each part, then calculate a weighted average of all these delivery times, based on the number of parts.

Criterion 4: integration of recycled materials (excluding plastics)

The progressive bonus remains in place. The calculation is based on the sum of all recycled material weights in relation to the total weight of the product.

The levels defined depend on the type of material integrated:

- For **pre- and post-consumer blends**, the premiums are - 5 %, - 10 % and - 20 % for 10 %, 20 % and 40 % recycled material respectively.
- For **post-consumer only**, they range from - 10 % to - 20 % for 10 % and 20 % of integrated material respectively.

These premiums are not cumulative. A given product can have only one bonus for the integration of recycled materials.



"Super-modulation" : incorporation of recycled plastics...

The criterion of incorporating recycled plastic materials (RPM) applies to certain Sport & Leisure products by 2026. These products are then not concerned by criterion no. 4 above.

This "super-modulation" applies to three resins:

polyethylenes (PE)

polypropylenes (PP)

polyamides (PA)

- For PRM from **post-consumer waste from EPR channels** (open loop), the calculation base is established on the basis of **450 € excluding VAT per tonne**.
- For PRM from **post-consumer WEEE and ASL** (closed loop), the calculation base is established on the basis of **540 € excluding VAT per tonne**.
- For PRM from **pre-consumer waste** (post-production), the calculation basis is established on the basis of **220 € excluding VAT per tonne**.

These tons of PRM are to be reduced to the mass of PRM in the equipment.

Example: 2000 references of a product containing 1 kg of PA from post-consumer waste in an open loop -> 2 t of PRM -> 900 € excluding VAT.

In 2026, an extension is planned to cover a large part of the perimeter, and other resins, excluding food grade.

The **premium on criterion no. 4** concerning other recycled materials is likely to change in 2026 to harmonize with the "super-modulation" on plastics. Premiums for recycled raw materials from pre-consumer waste are transitional and will be abolished from 2026.



Criterion 5: Product recyclability (penalties and premiums)

This criterion is separated into two:

- **Generally recyclable products (penalty):** Products with a recyclability rate of less than 50 % are subject to a 10 % penalty.
- **Generally non-recyclable products (bonus):** Products with a 50 % recyclability rate are eligible for a 10 % bonus, and products with a 95 % recyclability rate are eligible for a 50 % bonus.

This calculation must be carried out using the **recyclability calculation tool provided by Ecologic**.

A "super-modulation" in € / tonne for the integration of certain plastic resins has been created. The scope of products is different from criterion 4.
